## Holding of the 3rd Meeting of the "Council for International Development of Aviation Infrastructure"

Ministry of Land, Infrastructure, Transport and Tourism (MLIT) has established the "Council for International Development of Aviation Infrastructure" to actively promote the Japanese style aviation infrastructure abroad through public-private partnerships (PPP) and has been taking various actions, including business matching services taking advantage of visit overseas missions and intergovernmental meetings.
