1. General

These lists are required by the BASA Implementation Procedure for Airworthiness (IPA) between the FAA and JCAB, revision 1 dated November 1, 2019, and support the implementation of the IPA for products to be validated by JCAB for Airworthiness and Environmental Certification.

These lists will be further updated to incorporate its amendment of each standard, and to correct any errors.

2. Significant Standards Differences (SSD) Lists

JCAB has incorporated the equivalent of 14 CFR Parts 23, 25, 27, 29, 33 and 35 into the Airworthiness Inspection Manual (AIM) Parts II, III, IV, V, VII and VIII respectively. JCAB has also incorporated equivalent of 14 CFR Part 26 into AIM Part III-2 partially.

JCAB has incorporated the equivalent of ICAO Annex 16, Volumes I, II, and III, environmental requirements, into the Civil Aeronautics Regulations (CAR), Appendix 2, 3, and 4 respectively.

A) For small airplane, AIM Part II is identical to 14 CFR Part 23, §23.1529, and has included 14 CFR Part 23 Amendments 23-1 through 23-63, except Amendment 23-60.

JCAB incorporated the equivalent of SFAR-41 into AIM Part II, Chapter 8.
