1	<p><b>Construction output decreased</b></p> <p><b>Construction – July 2014</b></p> <p>チェコ統計局によると、2014年5月には建設業の生産高は前年同月比で3.7%減少した。計画・建設管理当局による建築許可数は前年同月比（以下同じ）2.8%増加。許可された建築物の価値は2.2%減少。住宅建築開始数は22.9%増加し、完工した住居数は4.5%減少した。</p>	2014/09/08 Czech Statistical Office
2	<p><b>The volume of public procurements increased to CZK 192 billion.</b></p> <p><b>Construction in the lead</b></p> <p>2014年上半期の公的入札の総額は前年比で43.3%増加し、1917億CZKとなった。特に建設業界での増加が主因であった。5年間の停滞から抜け出し再び成長基調となった。</p> <p>The volume of public procurements grew by 43.3% in the first half of 2014. In total, tenders for CZK 191.7 billion were announced. The growth is particularly evident in the construction industry.</p> <p>Growth in the volume of public procurement is seen mainly in the construction industry, which has a key share in the total procurement volume. Greater influx of work in the construction industry has been quite specifically reflected in the actual performance of the sector, which begins to grow again after 5 years of previous slumps; by even more than 5% in the period of the first 6 months of 2014. The persistent problem is not lack of money to invest, but unnecessary bureaucracy and delays in the preparation and construction itself.</p>	2014/08/14 E 15

3	<p><b>Number of public procurements last year rose by a quarter to 47,000</b></p> <p>昨年の公的入札数は25%増加して47,000になり、総額は660億 CZK となった。多くは土木工学、情報技術及び電子工学分野である。建設業がもっとも契約の総額が大きく、一件あたりの平均は 430 万 CZK である。</p> <p>Number of public procurement rose by 24% to 47,024 and their total value doubled to 66 billion last year. Most of them were announced in civil engineering, information technology and electronics.</p> <p>Most valuable contracts were in the construction industry, where their value is averaging CZK 4.3 million.</p> <p>Most public contracts are announced in August, which corresponds to the trend in the construction industry. On the other hand, only 3% of all public procurements were announced in December, which follows the same trend.</p>	2014/09/08 Financial News

4. その他我が国建設業界にとって参考となりうる最近の動向（報道情報以外）

2014-2020 年の欧州委員会による加盟国支援ガイドラインが 7 月 1 日に発効した。チェコに関しては投資に対する援助率が最大 40%から最大 25%に引き下げられた。チェコ政府はこれに対応して国内の制度を整備した。

New European Commission Guidelines for regional State aid 2014-2020 came into force on 1 July. The maximum possible intensity of state aid in the form of investment incentives in the Czech Republic has thus been reduced from 40% to 25% of eligible costs for large enterprises.

Following the Guidelines, the Government Provision No. 118/2014 amending Provision No. 569/2006 on maximum possible intensity of state aid in the cohesion regions of the Czech Republic was published 25th June and became effective from 1st July 2014.
