Last year, developers sold a record of 5,950 new flats in Prague, more than in the pre-crisis year 2007. Were it not for foreigners, the sales would hardly beat records. Every sixth flat is bought by a foreigner, HN notes, referring to data from the six biggest developers who sell over one half of all new flats in the capital. The Ejpovice tunnel on the line from Rokycany to Pilsen, consisting of two 4.5 km single-track tunnels, will shorten the original 20 km stretch of line by more than 6 km and will halve the running time taken by trains. Construction work is scheduled to be completed by 2017. Budget for investment in transport and backbone infrastructure, starting flats and nurseries will also increase. The government also promises to simplify and shorten the permitting process. Government wants to encourage starting entrepreneurs through soft loans, guarantees, capital inputs and guidance.

Attention will also be directed at small and medium-sized enterprises. The state-owned Czech-Moravian Guarantee and Development Bank also should help. The government also promises to reduce the administrative burden for businesses.

Amendment of the VAT Act in force from the 1st January 2015, which introduces the second reduced rate of VAT 10 % on the selected goods.

2015 年 1 月より、消費税 (VAT) に関して、今までの 21%、15%に加え、乳児用食品、 医薬品、本等のいくつかの品目について 10%が適用されている。

(Act No. 262/2014 Coll.) There are three VAT rates in the Czech Republic from 1. 1. 2015 - the basic VAT rate (21 %), the first reduced VAT (15 %) and the second reduced VAT (10 %). The 10 % VAT rate applies to the selected types of goods, such as: baby food, drugs and vaccines, printed books and sheet music (where advertisement covers less than 50 % of the surface). Other foodstuffs (items for gluten-free diet and phenylketonuria) with 10 % VAT rate are included in the Act. No 360/2014 Coll.

The second reduced VAT rate (10 %) was supplemented with grain mill products for gluten-free diet and phenylketonuria: cereals, products from edible fruits and nuts, peel of citrus fruit or melons and oil seeds and crops, various grains, seeds and fruits, industrial or medicinal plants straw and fodder, potatoes, dried legumes, sago, roots or tubers and mixtures of these mill products, as well as malt, starch, wheat gluten and mixtures of these products, modified mill products and ready-mix to prepare food for people intolerant to gluten.

Also, after 1.1.2015, the amount of turnover CZK 1,000,000 for 12 immediately preceding consecutive months for obligatory registration for VAT has remained without change (i.e. the reduction of the amount of turnover to CZK 750,000 for obligatory registration for VAT was cancelled).
